Research & Teaching Assignments

Research

- 1969-71** **Food Aid and International Economic Growth** (Jointly with Prof. Earl O Heady, Iowa State University). To look into the accrual and disbursement of PL 480 counterpart funds in India and suggest ways of disposal without inflationary impact. This study was completed in 1971 and published jointly with Professor Earl O Heady, Leo Mayer and Keith Rogers.
- 1974** **Planning and Implementation of Rural Development Projects by a Banking Organization** (Jointly with Prof. P.S. George). The study, undertaken for State Bank of India, was designed to evolve systems for providing loans to small farmers for purchase of cattle, marketing their surplus milk and recovery of loans over a reasonable period. The results were documented as a research monograph.
- 1975** **Planning and Implementation of Rural Development Projects by a Voluntary Agency** (Jointly with Prof. P.S. George). This study was designed to set up a semen freezing unit, cattle development centers and marketing of milk by the farmers and other activities of a voluntary agency engaged in rural development. Criteria were evolved for assessing the performance of cattle development centers and artificial insemination activities.
- 1975** **Bio-gas Plants at the Village Level : Problems and Prospects in Gujarat** (Jointly with Prof. T.K. Moulik, IIM, Ahmedabad). To analyze the performance and problems of bio-gas plants in Gujarat and to evolve a strategy for promoting these plants on a larger scale. The report was brought out in the form of a research monograph.
- 1976** **The Economics of Sunflower Cultivation and Processing with Special Reference to Tamil Nadu.** This study was designed to assess the economics of sunflower cultivation, processing and problems in promoting this oilseed. This report was completed in 1976 and brought out as a research monograph.
- 1977** **Planning and Implementation of Drought Prone Areas Programme : A Case Study of Joshua District, Madhya Pradesh.** This study was designed to analyze the planning and implementation process and assess the final impact of the programme on the beneficiaries in Jabhua district.
- Case studies of selected projects were undertaken. The report was completed and brought out in the form of a research monograph and later it was published in a book form.
- 1978** **Design Criteria on Convertibility Options,** The study was designed to analyze the stipulation and exercise of convertibility options by the all India term lending institutions. The analysis was aimed at an understanding of the existing criteria and to suggest the improvements. The project was completed in 1978 and later it was published in a book form.

- 1979** **Cost Effectiveness Study of Beggar's Home and Related Institutions in Gujarat**
 (Jointly with Dr.C.Rangarajan). This study was designed to examine the cost effectiveness of various institutions run by the Directorate of Social Defense for the weaker and vulnerable sections of the society. The study was completed in 1979 and the report was brought out as a research monograph.
- Management of Marine Fishing Industry : A Micro Study of Gujarat**,
 (Jointly with Prof. V.K.Gupta). This project was designed to understand the total operation beginning from catch and its uncertainty to final disposal of catch in Gujarat. In the process, the functions and margins of various marketing intermediaries were worked out. Economics of various types of boats and gears as well as processing operations was also worked out. The report was completed in July 1979 and it was brought out as a research monograph. It has now been brought out in a book form.
- 1980** **Rural Development Programme in India : An Analytical Review District Level** (Jointly with Binod C.Agrawal of ISRO). This project was designed :
- 1). to assess the understanding of the objectives of various rural development programmes at district level;
 - 2). To review the process of planning and implementation of various programmes at block and district levels. Evidence on the impact of the beneficiaries was also analyzed with a view to suggest measures to improve effectiveness of programme meant for rural poor. The project was completed in December 1980 and the report brought out in the form of an IIMA Working Paper.
- 1981** **Management of Agro-Industrial Projects**
 This project was designed to cover the entire project cycle of an agro-industrial project. The study covers concepts & case studies of selected agro-processing companies. It was published in a book form by the Indian Institute of Management, Ahmedabad.
- Estimation of Pesticides Demand : An Evaluation of Methodologies**
 (Jointly with G.A.Patel).
 The project was designed to review all the methodologies used for estimation of pesticide demand in India and to suggest modification of the models as well as steps to collect data on additional variables. The report was completed in November 1981 and it was published as a book in 1983.
- 1982** **Impact of Mechanization on Small Fishermen** (Jointly with V.K.Gupta).
 This project is designed to conduct detailed study of six fishing villages of Gujarat and Karnataka with a focus on socio-economic changes brought about by mechanization of boats. This project has been completed in June 1984.
- 1983** **Use of Windmills for Water Pumping** (Jointly with Prof. Girja Sharan).
 This study was designed to examine the performance of windmills in Gujarat and indicate the policy framework for expanding the programme in the seventh five year plan (1985-90).
- 1984** **Financing of Trade in Groundnut, Groundnut Processing Units and Distribution of Finished Products** , This study was sponsored by the Committee to Review the working of the Monetary System, Reserve Bank of

India, Bombay, primarily to understand the financing of various elements of the groundnut system. The paper covers each major element of the system at four stages:

- 1) Groundnut production system;
- 2) trade in groundnut seeds;
- 3) Processing of seeds by ghanies and mills and
- 4) Marketing and distribution of oil and oil cakes to the respective consumers.

The paper also goes into the analysis of price-spread over various elements of the system and finally tries to understand the finance used by various elements of the system from cultivation of groundnut seed to marketing of oil and oilcakes.

1986-89 Pesticide Industry in India - Issues and Constraints in its Growth

This study is designed to understand the structure of pesticides industry and its various constituents and to identify major issues which require Government policy support.

1989-93 Indepth Case Studies of Selected Processors and Exporters of Agricultural and Processed Food Products

This study was designed to generate an understanding of the constraints and problems in enhancing production and exports of agriculture and processed food products at the grass root level. The analysis and case studies were completed in January 1992.

1993 Planning, Appraisal, Financing of Agro Industrial Units

The study is designed to serve as a comprehensive manual for generating project ideas, preparation of feasibility reports, financing and implementation of agro-industrial projects.

1996 Conceptual Background and Course Designing for the National Institute of Cooperative Management (NICM, Gandhinagar)

The task was to prepare Vision, Mission, Structure and Activities of NICM.

1996 By product in Sugar Units, The study was designed to identify avenues of improving profitability through by product processing in Gujarat.
